Print Purchase Process

To view an individual artist's art, click on the link to their individual print gallery below their sample image.

To purchase a print of any image, please contact the individual artist who created it directly through their links in their listing on their individual artists print gallery page.

Individual artists will be using different printing processes and materials for their prints. Please discuss any questions you have about the printing process and materials used for final prints with the artist prior to purchasing.

The artist and buyer will negotiate arrangements for payment, shipping and/or delivery.

All purchases from the print gallery are FINAL unless prints arrive damaged through the shipping process and the shipper has been notified of a claim.

Terms of Sale

These Terms of Sale apply to all offers made by any artist represented in The Guild of Berkshire Artists Print Gallery at berkshireartists.org, all purchases and orders placed by you and all agreements concluded between us in relation to the products and services offered on this website.

Return Rights

If your order should arrive damaged, we offer a convenient photo replacement option. Simply take a digital photo of the item and one of the shipping containers it arrived in, attach it to an email and send to **the individual artist** you purchased the print from at the email address of that artist.

Please include in the body of the email: your order number, the shipping ID or item number, a brief description of the reason for the replacement. You will receive an email letting you know your replacement is being processed.

To return your item(s) please pack them in the original tube or box if possible. Be sure to specify the reason for the replacement. We strongly encourage you to return your item via a trackable method.

Sales Tax

Items shipped to destinations in the states of Alabama, California, Colorado, Connecticut, Hawaii, Illinois, Indiana, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts,

Michigan, Minnesota, Mississippi, Missouri, New York, North Carolina, North Dakota, Oklahoma, Pennsylvania, Rhode Island, South Dakota, Tennessee, Vermont, Washington, Wisconsin, and Ohio are subject to tax. No sales tax is charged when purchasing gift certificates; however, purchases paid for with gift certificates may be subject to tax.
